ADMISSION NOTICE

3rd Counseling for Selection and Spot Admission into the Post Graduate Courses in the 4(four) Medical Colleges of Assam for the Session 2015.

In pursuance of the Time Schedule fixed by the M.C.I. New Delhi, the 3rd counseling and admission into the Post Graduate courses in the four Medical Colleges of Assam for the session 2015 will be held on **4th June/2015**. Candidates whose names have appeared in the merit list of Post Graduate Entrance Examination-2015 conducted by S.S.U.H.S. Assam are hereby requested to physically appear for the said counseling and spot admission. Because of non availability of seats, 2nd counseling was not held.

Candidates to appear in counseling

- 1. For General Merit Candidates :-** All candidates of Un-reserved, Reserved category securing 50% marks and above P.G. Entrance Examination.

The candidates who secured minimum 50% marks after awarding 3% additional marks as per P.G. admission rule they should appear in the counseling.

- 2. For Reserved category Candidates :-** S.C, S.T.(P), S.T.(H), O.B.C./M.O.B.C. candidates and candidates of State Health Service (both General & Reserved categories) securing marks 40% and above & in P.G. Entrance Examination.

The candidates who secured minimum 40% marks after awarding 3% additional marks as per P.G. admission rule they should appear in the counseling on this day.

VENUE : Office of the Director of Medical Education, Assam Sixmile Khanapara Guwahati-22.

TIME : At 10.00 AM onwards.

IMPORTANT : A) The Candidates should come prepared for on the spot admission at the same time, date & venue of counseling along-with necessary admission fees/ counseling fees.

B) Candidates shall have to deposit the original documents as specified in Assam Medical College (Regulation of Admission to Post Graduate Courses) Rules, 2006 (Amendment up to 2012) at the time of admission.

C) After being selected the candidates admitted under State Quota shall execute a duly registered agreement on a non-judicial stamp paper of the value of Rs.100/- (Rupees one hundred) only in the format as appended in Appendix-II of the Assam Medical Colleges (Regulation of admission to Post Graduate Courses) Rules, 2006 (Amended upto 2012) at the time of spot admission. Necessary fee for registration of Agreement etc. shall have to be born by the candidates at time of admission.

D) Candidates must be able to show their Permanent Registration Certificate, certificate for Completion of one year Rural Service in Assam etc. at the time of counseling, otherwise they shall not be eligible for admission as per provision of admission Rules.

E) A candidate admitted into a particular subject shall not be allowed to change his/her subject or College subsequently during counseling under any circumstances.

F) The vacancy position will be displayed at the time of counseling.
