EDUCATIONAL NOTICE

Admission into 2(two) years Diploma in Pharmacy course in the Institute of Pharmacy attached to 3(three) Medical Colleges of Assam for the session 2013.

This is for general information of all candidates who appeared in the Common Entrance Examination 2013 conducted by the Srimanta Sankaradeva University of Health Sciences held on 4th August' 2013 for admission into 2(two) years Diploma in Pharmacy Course in Institute of Pharmacy attached to three Medical Colleges of Assam, that the counseling for selection of candidates for admission into 2(two) years Diploma in Pharmacy Course will held on 3rd & 4th October'2013 as per programme given below. Candidates applying under various reserved categories are required to produce the appropriate certificates/testimonials etc. in original issued by competent authority before the Selection Board.

Candidates must bring with them all original testimonials i.e. Marks sheets of 10+2, Admit Card of HSLC examination, Pass Certificates, PRC, Cast certificates and other relevant documents including Admit Card of Common Entrance Examination-2013. Separate Photo copies of the said will be required at the time of counseling.

All candidates should appear personally for counseling on the scheduled dates and time failing which he/she will forfeit his/her merit positions and no claim shall be considered later. In case of any matter of controversy, the decision of the Selection Board shall be final and binding.

Date of Counseling: 3rd October, 2013

(A) All candidates who have obtained marks 59 and above

(After filling-up of all un-reserved/general seats i.e. 102 seats in the 3(three) Institutes of Pharmacy attached to 3 Medical Colleges of Assam the remaining candidates belonging to SC, ST(P), ST(H) and OBC/MOBC reserved categories who secured marks 59 or above will be accommodated in their respective categories in order of merit.)

Date of Counseling: 4th October, 2013

(B) Candidates belonging to OBC/MOBC Category obtaining marks 58, 57, 56, 55, and 54 in order of merit.

(C) Candidates belonging to SCHEDULE CASTE category obtaining marks 58, 57, 56, 55, 54, 53, 52, and 51 in order of merit.

(D) Candidates belonging to ST(P) category obtaining marks 58, 57, 56, 55, 54, 53, 52, 51 and 50 in order of merit.

(E) All Candidates belonging to ST (H) category who appeared in the Entrance Examination.

(F) All Candidates belonging to TGL/Ex-TGL Category who appeared in the Entrance Examination.

(G) All Candidates belonging to Char Area category obtaining marks 58, 57 and 56 in order of merit.

(H) All Candidates belonging to Physically Handicapped Category who appeared in the Entrance Examination.

Important Note: The Candidates who secured same marks and rank in the Entrance Examination their inter-se merit will be decided as follows:

- (i) Candidates obtaining more marks in Biology/Maths in the Common Entrance Examination.
- (ii) In those cases where still there is a tie, the marks obtained by the candidate in Biology or Maths whichever is higher in H.S. Examination shall be taken into account for determining the merit position.
