**EMPLOYMENT NOTICE**

Government of Assam, Health & Family Welfare (B) Department invites eligible candidates for a Walk-in-Interview for recruitment under Regulation 3(f) of Assam Public Service Commission to the post of Registrar / Resident Surgeon / Resident Physician / Demonstrator / Anesthetist / Refractionist etc. in different Departments of the Medical Colleges of Assam against the existing vacancies and also the vacancies likely to be caused shortly.

All candidates who have passed their Post Graduate Degree courses in the year 2014 from the Medical Colleges of Assam and have signed the bond / Agreement as per the amended rule 12 of the Assam Medical Colleges (Regulation of Admission to Post Graduate Course) Rules, 2006 shall have to appear for the walk in interview if they are not already in the service of state Government of Assam and whose bond / Agreement has not already been discharged.

The candidates who passed in the previous years may also appear.

The amended rule 12 of the Assam Medical Colleges (Regulation of Admission to Post Graduate Course) Rules, 2006 amended on 11<sup>th</sup> January 2012 reads as under:

“12. Agreement – After being selected the Candidates admitted under State quota seats including candidates of Teachers Quota and State Health Service Quota shall execute a duly registered agreement on a non-judicial stamp paper of the value of Rs. 100/- (Rupees one hundred) only in the format as appended in Appendix-II.

The students who take admission in Post Graduate Courses under All India Quota in the Medical Colleges of Assam and are desirous to receive stipend awarded by the Govt. of Assam shall have to enter in to an agreement as executed by the State Quota Candidates (as in Appendix-II) binding himself / herself to serve under the Government of Assam for a period of 10 years on completion of Post Graduate Course and in breach thereof to pay a sum of Rs. 20.00 lakhs only to the Government as compensation and deliver the same to the Government. However, if any student from All India Quota does not want to receive the stipend, he/she shall be exempted from the purview of this agreement”

Keeping in view the above clause of the rule, it is hereby notified that for those candidates who come under the purview of this rule the period of service offered by the candidates under this advertisement shall be counted as service offered under fulfillment of the above stated agreement condition for the actual period of service offered by them to Govt. as per the advertisement.
